#### Job Purpose

The South Carolina Baptist Convention has a critical need to invest in the next generation of college students to help them experience the power of cooperative mission and ministry to introduce college students to the Baptist ministry being accomplished across our state and world. In our current culture, much of that is done through the production, design, and distribution of digital creative content.

The Creative Catalyst will participate in this mission and ministry by helping creatively communicate to their peers in order to help our convention see and serve the many young leaders in our state who have a passion for and understanding of God's work through South Carolina Baptists.

A successful Creative Catalyst would receive a mentor from the SCBaptist Creative Team to assist each student with their potential calling as a future church creative communicator, educate SCBaptist in how to best communicate creatively to Gen Z in order to increase our reach and engage of the next generation, and learn practically creative skills through a hands-on approach of learning-by-doing.

### **Duties and Purpose**

Under the direction of the Creative Team, depending upon the Catalyst's area of focus, a Creative Catalyst will:

- Complete tasks related to the pre-production, production, postproduction, and distribution process of audio, video, design, written and/or photo content
- Assist the Creative Team with regional on-location live events
- Receive mentoring towards their potential calling as a future creative or communicator
- Educate SCBaptist on best practices in communicating creatively to an audience of your peers to increase reach and engagement by that audience
- Be an active, participatory part of the team through a hands-on approach of "learning-by-doing"

#### Qualifications

A successful Creative Catalyst will have the following qualifications:

- Passion to serve Jesus and show promise toward serving as a leader and active member
  of an SCBaptist church, with a clear testimony of salvation, baptism, and renewed life in
  Christ.
- Teachable spirit, flexible attitude, ability to both give and receive constructive criticism professionally, and ability to manage the time that is needed to succeed in educational, ministerial, and vocational commitments.
- Ready to "roll up their sleeves" and learn by doing while providing regular communication, reliable transportation for participating in events and meetings, and completing tasks by the assigned deadline(s).

# **Working Conditions**
